### **DISCUSSION**

- Discussion about equipment shed on Town Line Road. Should we get pricing on something identical to what is already there or go another route and build new? Discussion about how large the building should be. Chris to get a measurement of the building that that we have and decide from there. It was brought up to possibly add on to the current Highway Garage. Discussion was held about how close to the creek that would be.

### **PLANNING BOARD: presented by Sharon Eltz**

- Discussion about subdivisions. If property is subdivided the road has to be built by the individual to town specifications. It then has to be approved by the town and the fire department. Road then gets turned over to the town to maintain.
- Barbara Allen is the new Planning Board Chairman
- Dan Dineen came and went over rules and regulations.
- Told that any new structure should actually go to the Planning Board first to be approved. The Planning Board said they could work together with Mike since he checks everything before he issues a permit.

### **BUILDING/CODE ENFORCEMENT: presented by Mike Andersen**

- Mott’s on Whitney Road is moving along.
- Mulhern’s pool on Brooks Hill is not fenced in yet, should be done today.
- Law’s on Doran Hill received their Certificate of Occupancy with some recommendations.
- Crandal’s on Allen Hill asked for some information on building a deck.
- Deiss’ on Factory Drive put in a pool. They did finally come get a permit but they still have not put in a pool alarm. Going to give them an order of remedy.
- Yales on Telephone built an addition to their garage. They believed it was part of the original permit, but it was not.
- Baker’s on Doran Hill have their pool alarm in and electrical done.
- Tetreault on Route 26 asked about building a fire escape/entrance to the upstairs.

**HIGHWAY: presented by Chris Smith**

- Went to a meeting for emergency funding for Storm Stella. There will be some money coming back. Was not notified about the meeting. County Legislator, Charles Sudbrink happened to call Bryce the evening before to let him know about it.
- Elwood Road is done and ready for oil and stone. Working on a couple more. Ditches and pot holes are filled in.
- The grader is still working fine.
- The pipe to get into field on Whitney Road is not working. Will have to look into either doing something else or taking it out completely.
