- NYSEG bills is still at a stand still
- NYSERTA sent notice that there is a grant for LED street lighting. Will look into it.
- Received 3 bids for the Town Hall renovations; CSC Construction for \$61,604.00, JBK Builders for \$44,900.00, and Prentice Enterprises for \$43,796.75.
 - Discussion was held about which contractor to go with. No exact start date yet but decided that once the work has been started it needs to be completed in a timely manner, can't drag out for months. Decided to give a 60 day time frame.

- The highway department has lost the buyer on the plow truck, will look into getting it sold another way.
- The property next door to the town hall appears to have been sold, will wait and see if it does not sell.
- John Walsh called Bryce back about the bill from last month that was decided to not pay. Mr. Walsh and Bryce had a conversation and it was decided that Mr. Walsh would eliminate the bill.
- The retirement paperwork has been completely filled out and sent in, waiting on a response now.
- There are 4 people up for re-election in 2017 if they are interested in running again.
- The Briggs re-evaluation that was never completed needs to be looked into again.
- Town Justice, Mr. Elwood still has not turned his books/paperwork into Debbie for her to audit. She has asked for it two times now. Going to send a letter to him asking one more time and if he still fails to turn it in board will have to let the Judicial Audit Board know that he has not complied.

- Mike Andersen filled the board in on an incident that happened to him by a resident while checking out a project being built.

PLANNING BOARD: presented by Sharon Eltz

- Sharon has emailed Linda Crowley about a training that is happening at the end of the month in Norwich. She has also asked her about getting together to go over the Planning Board book.
- Town Board has decided to have Jaymie send a letter to all planning board members inviting them to next board meeting to discuss some things that are not being done.

BUILDING/CODE ENFORCEMENT: presented by Mike Andersen

- Law's house is still moving along
- Johnson's deck has been completed; they may screen it in or add windows.
- Danielo's doublewide is going in
- Mott's have applied for a building permit for house on Whitney Road
- Calhouns have contacted about building a wood shed
- Hyer's have built a porch without getting a permit. Had confrontation with him, doesn't believe that he should have to have a permit, now into a court case.
- Mulhern's have applied for a pool permit, nothing happening yet

HIGHWAY: presented by Chris Smith

- Going to start digging ditches as soon as Dig Safe NY has completed
- Amnesty Day will be held on Saturday, May 13 and Monday, May 15. County just notified this same week that it was approved
- Had 1,000 ton of sand delivered. Fuller's were the best price and it included delivery. Will look into getting another 500 ton.
- Talked with Grant Street about the DEF and getting a 55 gallon drum of it. It will cost \$159 for the 55 gallons plus pump and hose. They recommended to just keep doing it the way it is being done now. In the winter they use 2 ½ gallon a week. Adding it by the bottle is less risk of contamination.
- Called Roberts in Lyle about renting a bin for scrap. They do not charge a rental fee, but do keep \$25 a ton on returned scrap.
- A man from NYS is trying to get money allotted back to the towns from the March snow storm. Chris will be meeting with him on Thursday.
- Chris will be meeting with Dan Petrella to go over everything about the CHIPS money. He has received 2 different letters and they both have a different amount.
- Dick White will be starting as a part time equipment operator
